**Waivers in Effect through June 30, 2011:**

- Waiver to permit the State to use a portion of Rapid Response funds to conduct incumbent worker training.
- Waiver of the funds transfer limit between Adult and Dislocated Worker Programs, to allow local areas to respond to the particular needs of their customers and labor markets.
- Waiver to permit the use of a portion of local area formula allocation funds to provide incumbent worker training.
- Waiver to permit implementation of (and reporting only) common measures in place of current measures
