Statutory and/or regulatory requirements to be waived:

Waiver of WIA Section 134 (a)(2)(B)(ii) and 20 CFR 665.200 (d) requiring the conduct of evaluations of workforce investment activities for adults, dislocated workers, and youth.

Waiver of WIA Section 134 (a)(2)(B)(iii) and 20 CFR 665.200 (e) requiring provision of incentive grants to local areas.

Actions undertaken to remove state or local barriers: There are no state or local barriers.

Goals and expected programmatic outcomes of waiver:

The reduction to five percent in the WIA allotment for Program Year 2011 Governor's Reserve funds restricts the commonwealth's ability to effectively fund and carry out all of the required statewide workforce investment activities. The current funding level in the Governor's Reserve is insufficient to cover the cost of evaluations and incentive grants to local areas.

The commonwealth's reduced funds are being used to cover all other applicable required activities per WIA Section 134 (a)(2) and 20 CFR 665.200 (Final Regulations).

Our goal in seeking this waiver is to ensure that the commonwealth may prioritize the use of Governor's Reserve funds for the required activities deemed most essential to the basic functions of the workforce investment system.

Individuals impacted by the waiver:

This waiver will provide the state agency with more flexibility in directing Governor's Reserve funds to those activities that best preserve basic functions of the statewide workforce investment system.

Process for monitoring progress in implementation:

The commonwealth will monitor progress and ensure accountability for federal funds in connection with these waivers by reviewing monthly expenditure, performance, and other reports; contacting the ETA Regional Office liaisons regularly; and using its monitoring and performance accountability system.

Notice to affected local boards:

The proposed waiver request was posted on the Commonwealth's official website from January 9, 2012 through January 20, 2012. Stakeholders were notified via e-mail regarding the posting of the waiver and the opportunity to comment. Pennsylvania's final waiver request was submitted to USDOL on January 25, 2012.

Public comment:

One public comment was received in support of this waiver request.

**Pennsylvania's Proposed Waiver for Some Requirements of the Workforce Investment Act of 1998 Due to Decreased Funding, Governors' Reserve; Public Comment Notice**

The Department of Labor & Industry invites comment on Pennsylvania's request for the U. S. Department of Labor's approval to waive some requirements of the Workforce Investment Act of 1998 (WIA), which are funded through the Governor's Reserve.

The waiver request is available on this website by clicking "Workforce Professionals," then "Reports/Policy Documents," then "Policy Documents."

**Background:**

On Oct. 26, 2011, ETA issued a Training and Employment Guidance Letter (TEGL) No. 9-11, which provided states with revised levels for WIA Adult and Dislocated Worker Fiscal Year 2012 "advance" funds, and clarified that the Governors' Reserve (statewide set-aside funds) is set at 5 percent for all Program Year 2011 WIA funds. Additionally, this TEGL clarified TEGL 26-10, issued May 10, 2011, which announced Program Year (PY) 2011 WIA allotments to states. In TEGL No. 26-10, states were informed that Congress decreased the level of PY2011 base funds that governors may reserve for statewide activities by 10 percentage points, from 15 to 5 percent. In TEGL No. 9-11, ETA allows states to request a waiver to exempt them from the requirement to carry out some of the required statewide activities described at 20 CFR 665.200(b)(i) that would have been financed with PY2011 funds. Pennsylvania is requesting a waiver that exempts the commonwealth from the requirements to:

- Conduct evaluations (WIA Section 134(a)(2)(B)(ii) and 20 CFR 665.200(d)), and
- Provide incentive grants to local areas (WIA Section 134(a)(2)(B)(iii) and 20 CFR 665.200(e))


